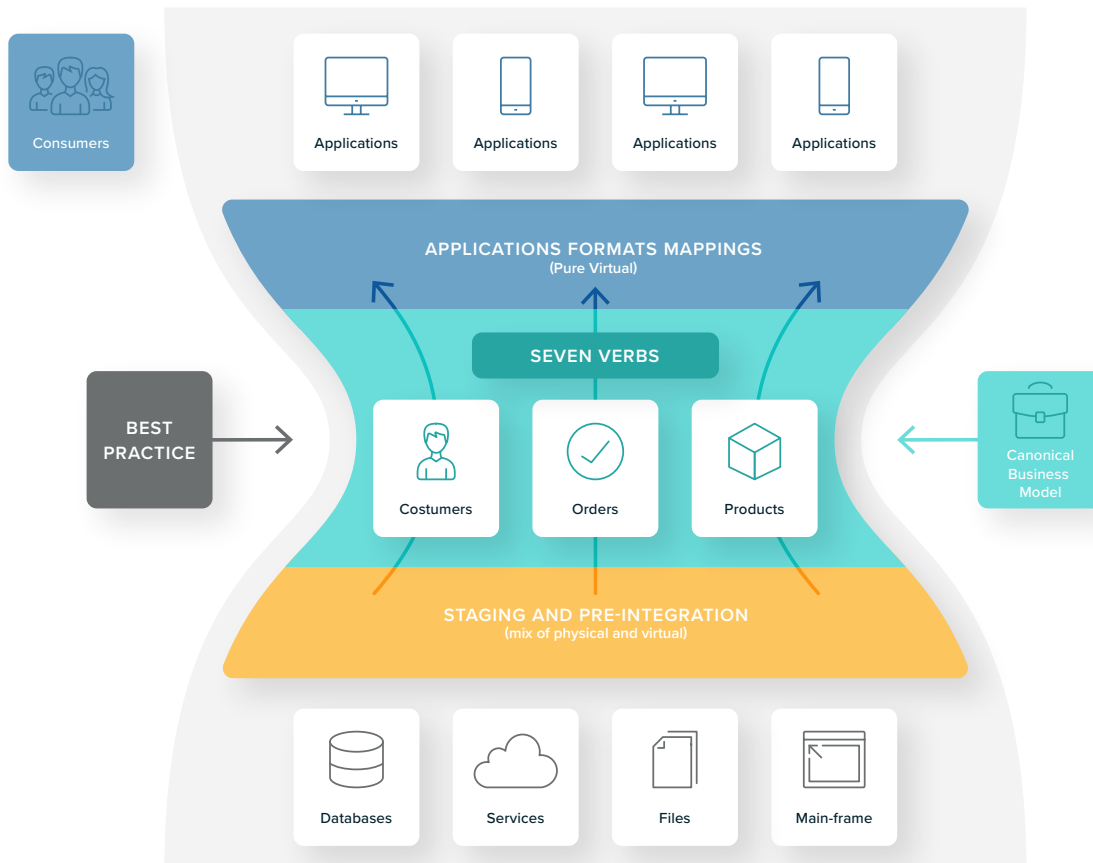


Figure 1 - Vision for agile info architecture - many to many
